STUDENTS CAN REGISTER FOR THE FOLLOWING EDUCATION PRODUCTS

LEADING UP TO THE EXAM

Study Material (Notes)

eBook Notes that can be printed or Hard Copy Notes that are delivered.

Additional material may be provided / prescribed by the course leader.

Tuition Full Package

Approximately 30 hours (50 hours for A311) of contact time, including an Exam Preparation session (may only apply to specific courses).

Marked assignments of at least 100 marks (compulsory).

1 x Content Practice Exam (CPE), marked with feedback before final exam (compulsory).

Short Course Package

Approximately 10 hours of contact time, including lectures on examtechniques (only applicable to A212 & A214).

Marked assignments of at least 100 marks (compulsory).

1 x Content Practice Exam (CPE), marked with feedback before final exam (compulsory).

Content Practice Exam (CPE) - standalone

1 x CPE, marked with feedback before final exam.

Marked assignments of at least 100 marks (optional).

Advancing Actuaries

Mentoring programme designed to support members to qualify at FASSA, AMASSA and TASSA levels.

F200 Examination Prep Sessional

F200 exam prep workshop hosted by the chairman of the Examination Board. There is no cost to attending the session.

Online Test Exam to test environment and technology.

Exam Counselling

One-on-one session post-exam. Applicable to the last exam sitting only.

Examiner's Workshop

Group session discussion to look at the past semester's exam with candidates having access to their script. First time exam candidates can also apply for this offering.

Syllabus	Published on the ASSA website. Updates to <u>syllabi</u> for the new year are published annually at the end of the current year.
Study material	F2 Level: Available in eBook format that can be printed or hard copy format also available. Hard copies for students outside of South Africa are available on request only and will include additional courier costs. Available on ASSA WebShop .
	All A–level, F1-level and N211 study notes are available on the <u>ActEd website</u> as eBooks. Course leaders may provide additional reading and notes where required.
	Notes packs for F207 / B200 and F107 / B100: Available in eBook format that can be printed or hard copy format available on request (Note that courier costs outside of SA will be for the student's account.) Available on ASSA web shop.
Tuition	Online Education Support Initiative (ESI) Course with an approximate 30 hours (50 hours for A311) of contact time, which may include lectures, one-on-one sessions, assignment sessions, workshops, pre-recorded videos, Content Practice Exam (CPE) and feedback, etc.
	Compulsory marked assignments of at least 100 marks. Assignments will be provided by the course leader or done through ThinkActuary, if available for the subject. (The course leader decides how to split assignments over the semester). Marked by the course leader or appointed assignment marker.
	Compulsory Content Practice Exam as described below. A session on exam preparation for the specific subject. (CPE for N311.03 is not available)
Short Course	Online short course with an approximate 10 hours with limited contact time including lectures on exam techniques, past exam question review and discussion points.
	Compulsory marked assignments of at least 100 marks. Assignments will be provided by the course leader. (The course leader decides how to split assignments over the semester). Marked by the course leader or appointed assignment marker.
	The Short Course includes a CPE, marked with feedback before final exam.
	NB. Short course only applicable to A212 & A214.
	This course is ideal if you have attempted the exam before and you are relatively familiar with the course content already.
Content Practice Exams (CPE)	Available on the ASSA Online Learning Platform. Marked and feedback provided to the student. Set by Course Leader and course leader peer-reviewed. CPE-only candidates also have access to the course assignments which are optional. CPE exams are also available for IFoA outsourced subjects through ASSA. Subjects that have 2 papers per CPE (A & B) are A212 / A213 / A214 and A311.
Advancing Actuaries (AA)	AA is a formal (mostly online) mentoring programme designed to support members to qualify at FASSA, AMASSA and TASSA levels. The emphasis is on psycho-social support with mentor/mentee training provided to equip both parties for a fruitful journey towards a significant exam that mentees are registered for and may have outstanding to qualify OR have been struggling with for some time.
Counselling	Will be available post final exams for that applicable exam session only. Format: realtime one-on-one session. Applicable - FA and FB candidates only.
F200 Exam Prep Workshop	A free exam preparation workshop for Fellowship (F2) level studies is held by the chairman of the Examination Board to assiststudents with exam technique. (This is not subject-specific).
Examiner's Workshop	(Post Exam) The subject-specific examiner takes participating candidates through the exam and trends that have been picked up in the exam session. Participants have access to their scripts from the previous semester's exam session. The workshop is applicable to the exam written in the previous semester only.
